RE: BC CHICKEN LIVE PRICE FORMULA DECISION

Dear Ms. Chojnacki,

At its August 2, 2019 board meeting, the BC Broiler Hatching Egg Commission (“the Commission”) further discussed the BC Chicken Marketing Board’s live pricing formula decision of June 27th, 2018 and the two appeals (by the Primary Poultry Processors Association and the BC Chicken Growers’ Association) arising from that decision.

In accordance with Rule 10 of the BC Farm Industry Review Board’s Rules of Practice and Procedure for Appeals, the Commission is applying for intervener status in these two appeals. As the broiler hatching egg sector is directly affected by the formula through the linkage between live and hatching egg pricing, the Commission’s participation in these proceedings on behalf of its regulated sector is important.

Although the Commission seeks approval to appear, give evidence and cross examine in the hearing of these appeals, it has yet to determine the extent to which this will be necessary pending further developments. The Commission is aware of the October 1-5, 2018 hearing dates and has no desire to prolong those proceedings.

Despite the necessity of this application, the Commission continues to rely on its July 13, 2018 correspondence (attached) to the Chicken Board and stakeholders regarding pricing in the BC chicken sector.

RE: LIVE PRICE FORMULA REVIEW

The BC Broiler Hatching Egg Commission has reviewed the BC Chicken Marketing Board's live pricing formula decision of June 27, 2018. The Commission is also aware of concerns expressed by other stakeholders in response to the decision.

1. The Commission currently has no specific comments regarding the revised pricing formula. Subject to any special circumstances arising, it intends to price off that formula – or as potentially amended by the BC Farm Industry Review Board – through the linkage. The Commission prefers not to introduce further uncertainty into the current situation.
2. This commitment expires at the end of Period A-154, following the completion of the Commission's and Chicken Board's review of the pricing linkage (which includes addressing premiums and the hatchery margin) and our respective costs of production. The Commission will assess the overall pricing situation at that time, including whether hatching egg producers are receiving a sustainable return that will also enable the industry to expand and address issues such as spiking barns.
3. The Commission remains concerned that the current overall approach to pricing in the Canadian chicken industry may be broken and is undermining orderly marketing. The outcome of the Ontario cost of production formula review is important for all BC stakeholders.
4. The Commission continues to rely on its earlier submissions in this process, and again points to the issues it identified in its April 18, 2018 position paper. A stable and transparent pricing system that is fair for all BC stakeholders is important in and of itself but also as part of an overall BC chicken sector strategy aimed at promoting and supporting a sustainable BC industry in the longer term. A unified BC approach will also support ongoing efforts to develop a western strategy.
